Sub: Stoppage of usage of PVC/Plastic Folder.

In pursuant to Ministry of Human Resource Development (MHRD) & Ministry of Environment, Forest and Climate Change letter mentioned under reference, attention is invited specially to PVC/Plastic folder being indiscriminately used in government institutions and offices for short term purpose. Poly Vinyl Chloride (PVC), a plastic polymer, is a non-biodegradable material and if burnt, releases toxic fumes such as dioxins, furans, etc. The harmful toxins may get bio-accumulated in the food chain of ecosystems causing a serious hazard to human health and environment.

In order to combat plastic pollution, reduction in use of avoidable plastics is necessary. Therefore, use of PVC/Plastic folders in government offices should be strictly avoided. Alternatives such as paper or card board folders, jute folders, etc. can be used in the offices. Such a step will help strengthen our national resolve to combat plastic pollution in the country.

In view of the above and by the directions of the Competent Authority, it is conveyed to all Students, Teaching Staff & Non-teaching Staff not to use Plastic Cover, bottles and all other goods made with single use plastic in both the Campuses of Central University of Gujarat and Hostels with immediate effect to help the environment stay clean and green under "Swachhata Hi Sewa Campaign".
