NOTIFICATION NO. 17/AAM- 2018-19

The University had constituted a Sub-Committee of the Academic Council vide its Notification No.15/AAM-2018-19 dated 20.08.2018 to look into the representations of some students forwarded by their respective Deans and the Liaison Officers SC/ST and OBC. The competent authority has accorded approval to the recommendations of the Committee and issued orders to implement them in the university as under.

1. The university will provide a relaxation of 5% marks from 55% to 50%, or an equivalent relaxation of grade to students belonging to SC/ST/ OBC (Non-Creamy Layer)/Differently-abled categories in eligibility criteria for admission to Ph.D. programme as per clause no. 3.2 of UGC (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degrees) Regulations, 2016. This relaxation will be provided to all such students who have enrolled in M.Phil-PhD integrated programs offered by university since A.Y. 2016-17 till date. However, the relaxation of 5% to the categories mentioned above will be permissible based only on the qualifying marks without including the grace mark procedures as per clause no. 2.2 of UGC Regulation 2016.
2. Such students who were admitted in M.Phil-PhD integrated programs offered by university in A.Y. 2017-18 and have completed the course work with 6.5 or more CGPA will have an option to continue in M.Phil. program to write dissertation or proceed directly for registration into Ph.D program. This will be a one-time enabling procedure applicable to students enrolled in A.Y. 2017-18 only. Students enrolled in subsequent years will be governed by the provisions of the relevant ordinance of the university.

Eligible students opting for registration into Ph.D program directly will have to submit an undertaking to the Admission Department that they will abide by any decision/direction of UGC in this regard and they will not lay claim for dual degrees at a later stage.
