Admission for Bachelor of Vocational Programme

Applications from eligible candidates are invited for admission to three year Bachelor of Vocational Course (B.Voc) in Rational Approach to Drug Design, for the academic session 2015-16. The course has been recently approved by the University Grants Commission. The course aims at providing the graduates of higher education system to have adequate knowledge and skills for employment and entrepreneurship and to also fulfil the emerging needs of the economy. The course aims to incorporate the requirements of pharmaceutical industries with specific job roles in its curriculum in an innovative and flexible manner. The B.Voc. Course therefore also provides an opportunity of exiting the course after completing 1 year with a Diploma (having NSQF Level 5), after completing 2 years with an Advance Diploma (having NSQF Level 6) and after completing the 3 years with Bachelor of Vocational Degree (having NSQF Level 7). The candidates belonging to the following category will be eligible for admission in the B.Voc. Course:

Category 1: Students who have already acquired NSQF certification level 4 in the industry sector belonging to Pharmaceutical

Category 2: Students who have acquired NSQF certification level 4 but may like to change their sector and pursue Vocational Course.

Category 3: Students who have passed (10+2) level examination in science stream (or equivalent) without any background of vocational training. Such students must have secured at least overall 50% marks at the 10+2 (or equivalent) level. Besides, they must have also secured at least 50% marks in Physics and Mathematics separately at the 10+2 (or equivalent) level.

Admission Fee: The total fee of the course will be Rupees Two Thousand five hundreds only (Rs. 2500/-) per semester. The admission form may be downloaded from the CUG website (www.cug.ac.in). The duly filled form along with a bank draft of Rs. 100/- (non-refundable) in favour of "Central University of Gujarat" payable at Gandhinagar, must reach the office of Dr. Prakash C. Jha, Nodal Officer, B. Voc, Room No. 2, Central University of Gujarat, Sector-30, Gandhinagar-382030 either in person or by post latest by **26.02.2016 up to 5:00 P.M.**

Admission Modality: The admission will be purely on merit basis. There will be no entrance test this year. Self-attested mark-sheets of the qualifying examination and of class 10th must be submitted along with the application. The list of the candidates admitted in the course will be displayed on the CUG website within 7 days of last date of application. The candidates are advised to visit the CUG website regularly for the latest updates. There are a total of 20 seats in the course. All other conditions for granting admission in CUG will remain same as mentioned in the CUG Prospectus 2015, which is available on the CUG website.
