**Sub: Effective use of Aarogyasetu App for breaking the chain of transmission of COVID - 19 reg.**

With reference to above, on the subject cited above, undersigned is directed to inform the following directions for compliance to improve the safety of all staff and students of Central University of Gujarat (CUG):-

- I. All teaching, non-teaching staff and students of CUG should download 'Aarogyasetu App' on their mobile phones immediately.
- II. Before starting for the University, they must review their status on 'Aarogyasetu App' and commute only when the app shows 'safe' or 'low' risk status.
- III. All teaching, non-teaching staff and students are advised that in case the App shows a message that **he/she has a 'moderate' or high risk** calculated on the basis of Bluetooth proximity ("recent contact with infected person"), **he/she should not come to the University and self-isolate for 14 days** or till the status becomes safe or low risk and inform to University immediately through email.
