In pursuance and compliance with the MHA Orders dated 30/05/2020 and Government of Gujarat Public Notice dated 30/05/2020 mentioned under reference 1&2 above, it is necessary to take effective measures to prevent the spread of COVID-19 Epidemic. Hence, I am directed by the competent authority to convey that the **lockdown period is extended upto 30/06/2020 at Central University of Gujarat (CUG) except essential services** to contain the spread of COVID 19. As per said MHA guidelines lockdown shall continue to remain in force in the containment zones till 30/06/2020.

All staff and students should follow the Guidelines of the MHA orders dated 30/05/2020 which is self-explained and attached herewith. Further, the orders and instruction already issued vide CUG Circulars dated 22/03/2020, 25/03/2020, 14/04/2020, 03/05/2020, 17/05/2020 & 19/05/2020 along with GoI/MHA orders can be seen and referred on the University website.

Further, it is also directed that the Administrative Offices will continue functioning as per Circular No. 12 dated 19/05/2020 mentioned under Reference-8 above. Other required Offices will be opened as and when required under essential services as per the MHA(GoI)/GoG/University Guidelines or staff of these Departments/Sections can be called as and when required.

Hostel Administration, Maintenance Section, Health Centre related activities will be continued as usual.

All are requested to kindly check the University website regularly for further instructions and updates.
