Revised Notification for the Election to the Office of the Students' Council (2017-18)

The office of Students' Council shall consist of the Elected Members as well as Nominated Members. Each school shall be represented by one elected and one nominated member in the Students' Council. However, the Independent Centres shall be represented by only the Elected Members. For the purpose, there shall be election to elect the elected member to the Students' Council.

For the above cited purpose, the Election to the Office of the Students' Council (2017-18) shall be held as per the schedule notified. The Election Committee (2017-18), which has been constituted and empowered for the purpose, shall conduct the entire election and all related affairs. The Election Committee is not answerable to any grievances and queries related to the nominated Students' Council Members and their nominations.

The candidates aspiring to represent their respective Schools/Independent Centres shall be voted by the Electoral College that will consist of the entire numbers of valid students in the same Schools/Independent Centres. Therefore, the concerned students are directed to vote as per this decision.

**All the candidates aspiring to represent their respective Schools/Independent Centre as "Elected Members" shall have to file Nomination compulsorily. There is no selection of candidates on consensus. If it is so, it can be legitimately established only after the official process of scrutiny is over.*

- a) All the concerned officials are hereby requested to take note of this notification. The entire Deans, Administrative Officers, the Proctor, the Provost and all the Wardens of the hostels have been appropriately intimated.
- b) The Office of the EC shall be the Office for the filling of nomination by the candidates. It is hereby instructed that the candidates including his/her Proposer and Secunder are only allowed to enter the Office of the EC for the said purpose.
- c) Any election related query and assistance required by the candidates shall be heard by the EC members and, in case of they being referred to the Office of the DSW, the DSW.
- d) The concerned office/administration is directed to issue bonafide certificate to all the students/research scholars of the current batch. The bonafide certificate must be duly signed by the assigned official(s) with attached passport size photograph of the issued person. In the case of absence of bonafide certificates, the registration slip/folio card of students/research scholars may be used for election purposes.
- e) All the students are requested to cooperate with the Election Committee Members and are requested to ensure that the university environment remains peaceful.
- f) Breach of Model Code of Conduct, violation of peace in the campus, and misbehaviour with the Election Committee Members shall amount to appropriate reporting by the members of EC to the concerned authority for strict disciplinary actions.
