#### "No Academic Arrear Guidelines" to be followed:

The Candidate fulfilling No Academic Arrear Guidelines must fulfil the following guidelines:

The Candidate must have fulfilled/submitted his/academic dues as per the prescribed credits and the time-frame prescribed for the particular course/degree he/she is pursuing for.

Further, the candidate should not have any type of academic overdue or debt beyond the prescribed time/semester for the particular course he/she is pursuing for. Therefore, he/she must have neither taken a zero- semester nor an extension beyond the normal duration (of the particular course he/she is pursuing for) during/for the last one year/ last two semesters from the date of notification for election whichever is applicable. Moreover, he/she must not have taken any extension/repetition beyond the prescribed credit: time limitation given in the Academic Ordinances of CUG concerning the same.

Further, counting of the above guidelines therefore, shall not be taken into consideration in the case of the "integrated courses/degrees, for which individual degrees provided by university for both of the courses/degree or the individual degree which has already been opted by the candidate".

However, the counting of the above is subject to the concerned/related provisions as given in the CUG Academic Ordinances, and/or as per provisions laid down in the Lyngdoh committee report.

- a. The Student's Copy of the Registration folio of the current semester given to the individual students dully signed by the competent authority at CUG, or,
- b. The fees receipts (admission/readmission/hostel fees) of the current semester given to the individual students dully signed by the competent authority at CUG.

#### Annexure F

# Code of Conducts to be strictly followed by the Candidates and his/her associates:

I. Candidate has to give all necessary official information without in distortion of facts and figures to the assigned competent authorities during the time of election whenever so required.

II. Candidates shall refrain from criticism of all aspects of private life, not connected with the public activities of the other candidates or supporters of such other candidates.

III. Criticism of other candidates or their supporters based on unverified allegations or distortions shall be avoided.

IV. Criticism of other candidates that is only during the Official Debates shall be confined to their policies and programmes, past record and work.

V. No candidate shall be permitted to make use of printed posters, printed pamphlets, or any other printed material for the purpose of canvassing.

VI. No candidates shall be permitted to carry out processions or public meetings or in any way canvas or distribute propaganda outside the University / College campus.

VII. No candidate shall, nor shall his / her supporters, deface or cause any destruction to any property of the University / College campus, for any purpose whatsoever, without the prior written permission of the College / University authorities. All candidates shall be held jointly and severally liable for any destruction/defacing of any University/College property.

# VIII. On the day of the polling, students involved with the candidates whatsoever purpose including their proposer and seconder and the candidates themselves:

- A. shall co-operate with the officers on election duty to ensure peaceful and orderly polling and complete freedom to then voters to exercise their franchise without being subject to any annoyance or obstruction;
- B. shall not serve or distribute any eatables, or other solid and liquid consumables, except water on polling day;
- C shall not hand out any propaganda/documents/papers inciting his/her support or with the intention of the wooing/intimidation of the other contestant on the polling day

Excepting the voters, no one without a valid pass / letter of authority from the election committee or from the College / University authorities shall enter the polling booths.

#### Annexure G

### 1. Model Code of Conduct

I. The Model Code of Conduct (MCC) is a set of norms to enforced and followed by all the stake holders of the university during the period of election. This is to ensure for conducting free and fair elections.

- II. The MCC binds all the stake-holders to respect and observe it in letter and spirit. (All the stake holders of the university include the students, the teachers, the working staffs and the other associates).
- III. This shall come to force just from the date and time of the notification for the declarations of elections to the period of the declaration of the results.

# 2. Set of Norms (MCC) to be followed and imposed:

Set of Norms (MCC) to be followed and enforced during elections through proper notifications and further intimated to the Candidates; as the followings are to be ensured by the EC:

I. There shall be no activity, which may aggravate existing differences or create mutual hatred or cause tension between different caste and communities, religious or linguistic, or between any group(s) of students.

II. There shall be no appeal to caste or communal feelings for securing votes. Places of worship, within or without the campus shall not be used for election propaganda.

III. There cannot at any circumstance of indulging or abetting, all activities which are considered to be "corrupt practices" and offences, such as bribing of voters, intimidation of voters, impersonation of voters.

IV. Canvassing or the use of propaganda within 100 meters of polling stations, holding public meetings before the period of 24 hours of the poll and after twenty four hours from the ending hours of the poll, and the transport and convenience of voters by the candidates during the polling time are strictly debarred.

V. The Candidates except casting his/her vote cannot enter the polling booth, and cannot campaign/woe the voters during the polling day and on the day of polling.

VI. Any canvassing before the Twenty Four Hour of Polling is strictly debarred.

VII. Further, any short of campaigning after the 10 PM by the Candidates esp. in the university hostels/hostels under the University supervision/control are strictly debarred.

VIII. There cannot be posting of Posters/banners/pamphlet/or wall painting/wall writing inside the any campus of the university is strictly prohibited after the notification for election is given. This shall be strictly followed by any stakeholder of the university till the final result of the election is over.

IX. During the prescribed and notified period for campaigning/canvassing the candidates may hold processions and /or public meetings provided that such processions and / or public meetings do not. in any matter, disturb the classes and other academic and co-curricular activities of the University. Further, such procession / public meeting shall not be held without the prior written permission of the EC.

X. The use of loudspeakers, vehicles and animals for the purpose of canvassing shall be prohibited.

XI. All candidates shall be jointly responsible for ensuring the cleaning up of the polling area within 48 hours of the conclusion of polling.

XII. Any contravention of any of the above recommendations may make the candidate liable to be stripped of his candidature, or his elected post, as the case may be. The election commission may recommend the appropriate disciplinary authority to take necessary action against such a violator.

XIII. In addition to the above mentioned code of conduct, it is also recommended that certain provisions of the Indian penal code, 1860 (as given in the section 153A and chapter ix A "Offences Relating to Election" of the LCR), may also be made applicable to student elections.
