### **Notification No. 21/AAM-2018-19**

University Grants Commission has recently notified several regulations and directed all universities to amend their ordinances in line with them. Accordingly, these regulations, along with other important ordinances, were placed before the University Committee for Statutes and Ordinances. The Committee deliberated at length upon all the issues involved therein and recommended that sub-committees may be constituted to look into these regulations and ordinances separately and they may be entrusted with the task of framing draft ordinances on policy matters mentioned below. The drafts so prepared, in turn, will be scrutinized by the Statutes and Ordinances Committee and submitted to the administration for further necessary action.
