Sub: Guidelines relating to eligibility criteria for recognition of Research Supervisor in Central University of Gujarat.

In pursuance of the Resolution No. 2 (Table Agenda) of Academic Council Meeting dated 28/09/2015, Guidelines relating eligibility criteria for recognition of Research Supervisor at CUG, are hereby notified as under:

### A. Eligibility Criteria for being recognized as a Ph. D. Supervisor.

- 1. Only regular teachers will be recognized as supervisors for Ph. D Students.
- All the Associate Professors and Professors would be recognized as research supervisors of the university in their respective disciplines from the date of their appointment.
- 3. All Assistant Professors are eligible to be recognized as research supervisors for students, if they possess the following qualifications and experience.
  - a) Possess a Ph.D. degree in the concerned or cognate subject.
  - b) Should have teaching and /or research experience of at least three years either in this university or in a UGC or any other Government recognized institution at the level of Assistant Professor or equivalent level on regular basis.
  - c) Should have published minimum of three researches papers in peer reviewed journals.
  - d) An Assistant Professor acquiring a Ph.D. degree in service could be considered for recognition as research supervisors from a month after the award of the degree (Via Notification), provided s/he fulfils the other requirements.
- 4. All Assistant Professors would have to apply to the office of the Registrar with the recommendation of the Chairman of the Center or the Dean of the School duly approved by the concerned CASR as per the eligibility criteria stated above. The Registrar would issue a notification of recognition as research supervisors with the approval of the Vice Chancellor.
- 5. If any teacher joins this university after having served in another academic institution where in s/he has been supervising research students and continues to do so after joining this university, this has to be disclosed at the time of application for research supervision.

- B. Criteria for being recognizing as M.Phil. supervisor:
  - 1. All the regular teachers of university who possess atleast M.Phil. degree are eligible to supervise M.Phil. Students.
- C. Visiting faculty, Adjunct faculty and faculty on contract basis are not eligible to Supervise M.Phil. and Ph.D. Students.
