**Eligibility Conditions:**

**For Assistant Professor:**

1. Good academic record as defined by the concerned university with at least 55% marks for GM category and 50% marks for SC/ST/Differently abled (Physically and visually differently abled) categories (or an equivalent grade in a point scale

wherever grading system followed) at the M. Pharm. level from Indian University or an equivalent degree from an accredited foreign university.

2. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET/GATE) conducted by the UGC/CSIR/AICTE or similar test accredited by the UGC like SLET/SET.
3. Candidates, who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET/GATE.
4. Preference will be given to the Ph.D. holder having at least one year of Postdoctoral experience from India/Abroad.
