

**NOTICE INVITING PRICE-BID FOR SALE / DISPOSAL OF SERVICEABLE /
UNSERVICEABLE FURNITURE, ELECTRICAL FITTINGS & FIXTURES AND
OTHER MISCELLANEOUS ITEMS.**

CUG intends to invite price-bids for sale / disposal of various old serviceable / unserviceable wooden / steel furniture / Computer related items (viz. tables, chairs, damaged partitions, electrical fittings and fixtures and other miscellaneous items) lying in many buildings located in Sector-29 and 30 Campuses of the University at Gandhinagar on "as is where is basis". Interested parties may inspect the items and submit their sealed offer to the Registrar, Central University of Gujarat, Sector-29, Gandhinagar.

The interested parties/individuals are requested to visit the University for inspection of goods from 15.06.2018 to 20.06.2018 from 10:30 hrs to 3:00 hrs. The last date for submission of filled-in Price-Bid Proforma is on or before 22.06.2018 up to 15.00 hrs. and the same will be opened on 22.06.2018 on 16.00 hrs. in presence of authorized representative of the bidders. The Competent Authority of the University reserves the right to accept or reject any / or all the bids at his own discretion without assigning any reason whatsoever.

Terms & Conditions

1. **Tender Fee:** There will be NO tender fee for the above tender.
2. **Earnest Money Deposit (EMD):** The tender should be accompanied by a Demand Draft / Pay Order as Earnest Money Deposit (non-interest bearing) of **Rs.3000/- (Rupees Three Thousand Only)**.

The Earnest Money Deposit should be paid by way of Demand Draft/ Pay Order in favour of "Central University of Gujarat, Gandhinagar".

For unsuccessful bidders, the same instrument may be returned without encashing. However, the **EMD of successful bidder will be returned on the receipt of a Bank Guarantee as specified by CUG** either through the same instrument or through the cheque issued in their favour by CUG.

3. The successful Bidder will be required to deposit the amount quoted in full within 7 (Seven) days from the date of issue of the Award Letter. The payment for the sold items shall be deposited in the form of Bank DD in favour of Central University of Gujarat payable at Gandhinagar. Any complaint about the quantity / quality or condition of the material will not be entertained after opening of the price-quote. The items would be handed over to the highest Bidder (H1) on "as is where is basis". CUG shall not be responsible for their usefulness or quality.
4. **A Lump - Sum amount (consolidated amount) is to be quoted** for the entire lot mentioned in the Annexure – I (enclosed). The quotation not received in **Annexure – I (Prescribed Price-Bid Proforma)** will be summarily rejected. Any rate quoted for items in part or in any manner over the whole lot of items shall not be accepted and such Quote will be summarily rejected
5. The Bidders are advised to inspect items earmarked by the office for sale / disposal before submitting their Quote. The intending bidders may verify and satisfy themselves with the quantities as well as quality / condition of materials lying at the site and submit their Quote accordingly. CUG will bear no responsibility in this regard. NO Claim whatsoever w.r.t. the quantities / quality / condition of said materials or otherwise will be entertainable / payable after submission of bid by intending tenders.
6. **Items offered are on "as is & where is basis "**.
7. The rates quoted by the bidders for purchase will be all inclusive and on "as is & where is basis ". Any Statutory or other charges, if applicable , shall be borne / paid by the bidder.

8. The Bidder shall take full responsibility in case of any damage, loss or injury to any person / building or to any part thereof, and shall repair / and make good the loss, at his own cost.
9. No other items except those mentioned above in Annexure - I are to be removed.
10. Conditional tenders / deviations from terms & conditions of tender shall be liable for rejection.
11. The tenderers shall quote the rates clearly both in figures and words and should be prefixed by the word Rupees and avoid overwriting. Tenderers should sign all cutting / over writings.
12. The security/ watch and ward of the materials will be the sole responsibility of the contractor.
13. It will be the sole responsibility of the successful bidder to ensure the safety of the structure and other materials to save them from damage etc. at the time of dismantling, removing, stacking, lifting carting and disposing the materials / malba etc.
14. The quoted amount will be firm and final till the sale deed is over.
15. All disputes will be subject to Ahmedabad Jurisdiction only.
16. The quoted amount shall also include the cost of expenditures likely to be incurred in all activities like dismantling, removing, stacking and lifting / transporting of all the materials / malba obtained from dismantling from work site to the vendors own dump. Under no circumstance , CUG will pay any extra charges on account of the above.
17. The tenderer will observe all necessary precautions at his own cost to safeguard his workers during execution of work. In case of any accident / mis-happening, contractor will be responsible for the safety of his workers & CUG will not take any responsibility in this regard.
18. All the materials sold through this bid are to be removed from the buildings within 7 days from the date of the Acceptance Letter and realization of payment to the University.
19. Removal of materials shall be done in presence of Deptt. Officials,

The Competent Authority of the CUG reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever and his decision in case of doubt / dispute shall be final & binding on both the parties.
