Admission Notification

Ph.D. Programme AY 2022-23

1. Central University of Gujarat invites application for admission to the Ph.D. programmes for the Academic Year 2022-23 on all India basis. Eligible candidates can apply for admission using this link https://cugadm.samarth.edu.in

2. Candidates for admission to the Ph.D. programme shall have a Master's degree with 55% marks in aggregate or its equivalent grade B in the UGC 7- points scale as per UGC Regulations 2016 (A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade in Master's degree may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/differently-abled and other categories of candidates) as per Govt. of India norms. It is the applicant's responsibility to ensure that s/he fulfils the eligibility criteria for a particular

programme where s/he is an applicant.

3. The selection of candidates for admission to research programmes (Ph. D.) would be based on a two-tier system (Entrance Test and Interview) as prescribed by UGC (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degrees) Regulations, 2016 and as amended from time to time. Accordingly, as per 1st amendment 2018 of UGC Regulations 2016 a relaxation of 5% of marks (from 50% to 45%) shall be allowed for the candidates belonging to SC/ST/OBC(Non-Creamy Layers)/Differently-abled category in the entrance test conducted by the CUG.

Further, as per 2nd amendment, 2018 of UGC Regulations, for the selection of candidates, a weightage of 70% for the entrance test and 30% to the performance in the interview/viva-voce shall be given.

Selection criteria	A weightage of 70% for the entrance test and 30% to the performance in the interview/viva-voce shall be given.

The selection for admission shall b	e based on the marks secured in Entrance terview. The merit list will be prepared

The CUG entrance test be made mandatory for all candidates, providing a level playing field for all aspirants to compete. No exemption will be granted to UGC-NET (including JRF)/UGC-CSIR NET (including JRF)/SLET/GATE/teacher fellowship holders or those who have completed an M.Phil. program for the written entrance test. The CUG entrance exam is mandatory for all candidates.

6. The application form should be completed online only, applications sent by any

other mode shall be rejected.

7. Applicants are required to provide all the mandatory information [Marked with * (asterisk) sign] in the application form. Incomplete applications or applications submitted without proper photograph, signature, or supporting documents shall be rejected. Therefore, applicants should ensure that the status of the Application Form is "Submitted Successfully".

8. The University holds the right to cancel the application and admission of any candidate for wrongful submission of facts pertaining to qualification, reservation

and/or any other matters

The candidates can apply for three (03) Ph.D. Programmes as per eligibility by

paying application fee as mentioned above.
