## GENERAL INSTRUCTIONS TO CANDIDATES FOR ADMISSION IN 4-YEAR B.A. PROGRAMMES FOR THE AY 2023-24

1. The merit list of provisionally selected candidates in following Undergraduate programme will be available on university website [www.cug.ac.in](http://www.cug.ac.in). **All candidates are advised to visit University website regularly for admission related information and updates.**

1.	4-year B.A. Degree (Honours with Research) in German Studies
2.	4-year B.A. Degree (Honours with Research) in Chinese
3.	4-year B.A. Degree (Honours with Research) in Social Management

2. Provisionally selected candidates will be given two working days' time to deposit programme fees to confirm the admission in respective programme.
3. A candidate appearing for admissions at CUG through CUET-2023 (UG) must have appeared in the final examination of the qualifying degree and declared passed with minimum required percentage as per the eligibility criteria mentioned for the said programme. Applicants awaiting the result in the qualifying examination may apply, however, their admission shall be subject to minimum eligibility marks in the qualifying examination.
4. Admission in Central University of Gujarat shall be subject to applicants fulfilling all the eligibility criteria as mentioned on the University website. It is the applicant's responsibility to ensure that s/he fulfils the eligibility criteria for a particular programme where s/he is an applicant.
5. The candidates whose qualifying examination results are not declared at the time of admission will be given provisional admission at CUG and they need to submit the marks sheet of the qualifying examination to the admission department latest by **31<sup>st</sup> December 2023**. If such candidates fail to secure the required percentage of marks in their qualifying examination or fail in the said examination their admission would automatically stand cancelled.
6. During admission, if a candidate is not able to provide some of the necessary documents/certificates, her/his admission shall be considered provisional. The last date of submission of any of the pending documents/certificates is **31<sup>st</sup> December 2023** failing which the admission of the student shall be liable to be cancelled.
7. If any candidate's certificates including degree certificate, birth certificate, caste or income certificates etc., are found to be fake/fabricated/falsified at any point of time



during or after the course of study, the admission of such a student shall be cancelled or if degree has been awarded, it will be declared null and void.

8. The selected candidates shall be required to pay requisite fee of the programme in which s/he has been offered admission. In case, if any student fails to deposit fees within the stipulated period, his/her offer for admission shall stand cancelled and other candidates from the waiting list will be considered for the admission purely on merit basis.
9. All the admitted students shall have to submit Migration/Transfer Certificate from their respective previous University/College/School positively before **31<sup>st</sup> December 2023**.
10. As per the orders of Hon'ble Supreme Court of India, ragging of any kind is prohibited within and outside the premises of the University. Any student found guilty of involved in ragging and/or abetting ragging is liable to be punished appropriately as per rules of the University/UGC guidelines.
11. The University holds the right to cancel the application and admission of any candidate for wrongful submission of facts pertaining to qualification, reservation and/or any other matters.
