GENERAL INSTRUCTIONS TO CANDIDATES FOR ADMISSION IN RESEARCH PROGRAMMES FOR THE AY 2023-24

1. The merit list of provisionally selected candidates in following Research programmes will be available on university website www.cug.ac.in. **All candidates are advised to visit University website regularly for admission related information and updates.**

2. Admission in Central University of Gujarat shall be subject to applicants fulfilling all the eligibility criteria as mentioned on the University website. It is the applicant's responsibility to ensure that s/he fulfils the eligibility criteria for a particular programme where s/he is an applicant.
3. It must be noted that allowing a candidate to appear in the Entrance Test and Interview and completing the process of provisional admission does not entitle a candidate for confirmed admission **if she/he fails to fulfil the required eligibility conditions for admission** and as amended and displayed on University website from time to time.

4. The documents and eligibility will be verified at the time of admission and subsequently at any stage during the pursuance of the course/programme or thereafter. If it is found at any point of time that a candidate has failed to fulfil the minimum eligibility requirements, the provisional admission or degree shall stand cancelled forthwith.
5. Candidate must have appeared in the final examination of the qualifying degree and declared passed with minimum required percentage as per the eligibility criteria. However, their admission shall be subject to minimum eligibility marks in the qualifying examination and they may be allowed to seek admission only on the submission of their final year mark-sheet on or before the last date of admission.
6. Provisionally selected candidates are required to complete the enrollment process online. Login id and password for the enrolment will be same as used at the time of Ph.D. registration process.
7. If a student is not able to provide some of the requisite documents/certificates except the qualifying examination mark-sheets at the time of admission, she/he shall be considered as provisionally admitted. Last date of submission of any of the pending documents/certificates is **30th September 2023** failing which the student shall be liable for her/his admission to be cancelled.
8. During admission, if a candidate is not able to provide some of the necessary documents/certificates, her/his admission shall be considered provisional. The last date of submission of any of the pending documents/certificates is **30th September 2023** failing which the admission of the student shall be liable to be cancelled.
9. If any candidate's certificates including degree certificate, birth certificate, caste or income certificates etc., are found to be fake/fabricated/falsified at any point of time during or after the course of study, the admission of such a student shall be cancelled or if degree has been awarded, it will be declared null and void.
10. The selected candidates shall be required to pay requisite fee of the programme in which s/he has been offered admission. In case, if any student fails to deposit fees within the stipulated period, his/her offer for admission shall stand cancelled and other candidates from the waiting list will be considered for the admission purely on merit basis.
11. All the admitted students shall have to submit Migration/Transfer Certificate from their respective previous University/College/School positively before **30st September 2023**.
12. As per the orders of Hon'ble Supreme Court of India, ragging of any kind is prohibited within and outside the premises of the University. Any student found guilty of involved in ragging and/or abetting ragging is liable to be punished appropriately as per rules of the University/UGC guidelines.
13. The University holds the right to cancel the application and admission of any candidate for wrongful submission of facts pertaining to qualification, reservation and/or any other matters.
