Admission Procedure for Ph.D. Programme (AY 2024-2025)

1. Eligibility Criteria for admission to Ph.D. Programme (Academic-year 2024-2025)

- 1.1. Candidates who have successfully completed their Master's Degree Programme in compliance with the stipulated eligibility criteria as per the University Grants Commission (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations, 2022 dated 07/11/2022 are eligible for admission to Ph.D. Programme.
- 1.2. In addition, as per UGC Public Notice F.4-1(UGC-NET Review Committee)/2024(NET)/140648 dated 27-March-2024 those candidates who have "**Successfully Qualified**" NET examination (UGC-NET, CSIR-UGC-NET) and have NET score in any of the below mentioned categories are eligible for admission to Ph.D. Programme for the academic-year 2024-2025:

- Category-1:** Eligible for admission to Ph.D. with JRF and appointment as Assistant Professor.
- Category-2:** Eligible for admission to Ph.D. without JRF and appointment as Assistant Professor
- Category-3:** Eligible for admission to Ph.D. programme only and not for the award of JRF or appointment as Assistant Professor.

The same is summarised as under:

The NET score will be used for admission to Ph.D. Programme from the academic session 2024-25.

- 1.2.1. The JRF-qualified students are admitted into the Ph.D. programme based on an interview as per the University Grants Commission


(Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations. 2022.

1.2.2. The result of NET in percentile along with the marks obtained by a candidate will be utilized as the marks for admission to Ph.D. Programme (i.e. NET Score).

1.2.3. For students who qualify in Categories 2 and 3, 70% weightage will be given for test scores (i.e. NET Score) and 30% weightage for the interview for admission to Ph.D. programmes. The Ph.D. admission will be based on the combined merit of NET marks (i.e. NET Score) and the marks obtained in the interview/viva voce.

1.2.5. The marks obtained in the NET (i.e. NET Score) by the candidates in Categories 2 and 3 will be valid for a period of **ONE YEAR** for admission to Ph.D. Programme.

2. Reservation of Seats in Admission:

The University shall follow reservation in admission as per GOI reservation policy and the Rights of Persons with Disabilities Act, 2016, as amended from time-to-time.

3. Only those candidates whose result of the qualifying examinations as mentioned hereinabove is clear in all respects on the last date prescribed for admission to the Ph.D. Programme will be considered eligible for admission to the Ph.D. programme.
4. Aspiring candidate for admission to the Ph.D. Programme is required to submit all requisite documents in original within the prescribed time frame failing which his/her candidature for the admission in the Ph.D. Programme for AY 2024-25 in the University shall stand cancelled.
5. All candidates are hereby requested to visit the Central University of Gujarat website regularly for updates. All information will be updated on the University website <https://cug.ac.in> regularly. **The list of Qualified and Not-qualified candidates for the Interview and Admission Process will be displayed on the University website after the last date of Online application. No separate communication will be made to individual candidates.**
