GENERAL INSTRUCTIONS TO CANDIDATES FOR ADMISSION IN UG PROGRAMMES FOR THE AY 2024-25

1. The Merit-list of provisionally selected candidates in following Under-graduate programme is available on university website www.cug.ac.in. All candidates are advised to visit University website regularly for admission related information and updates.

1.	4-year B.A. Degree (Honours with Research) in German Studies
2.	4-year B.A. Degree (Honours with Research) in Chinese
3.	4-year B.A. Degree (Honours with Research) in Social Management

- 2. Provisionally selected candidates are hereby informed to pay their Admission fee to confirm the admission in respective programme within the stipulated time. (As mentioned on the merit-list)
- 3. Admission in Central University of Gujarat shall be subject to the condition that an applicant fulfilling all the eligibility criteria as mentioned on the University website at the time of the admission. It is the applicant's responsibility to ensure fulfilment of the eligibility criteria for a respective programme.
- 4. A candidate appearing for admissions at CUG through CUET PG 2024 must have appeared in the final examination of the qualifying degree and declared "PASSED" and should possess the minimum eligibility marks as per the eligibility criteria of the respective programme.
- 5. Applicants awaiting the result of qualifying examination may also apply for the concerned programme, however, their admission shall be subject to PASSING the qualifying examination obtaining the minimum eligibility marks as per the eligibility criteria of the respective programme.
- 6. Those candidates whose result of qualifying examination is not declared at the time of admission; they will be "Provisionally Admitted" for their respective programme at CUG". If such a candidate fails to secure the required qualifying percentage of marks for admission as per eligibility criteria of respective programme and/or "FAIL" at the qualifying examination, as the case may be, their admission would be liable to be cancelled without assigning any reason(s) thereof whatsoever. A candidate meeting the eligibility requirement is required to submit the relevant document of the qualifying examination to the Admission department latest by 13th October 2024, failing which the admission shall be liable to be cancelled without assigning any reason(s) thereof whatsoever.
- 7. During admission, if a candidate is not able to provide some of the necessary documents/certificates, the admission shall be considered "Provisional The last date of submission of any of the

documents/certificates is **13**th **October 2024** failing which the admission shall be liable to be cancelled without assigning any reason(s) thereof whatsoever.

- 8. The selected candidates shall be required to pay the requisite Admission fee within stipulated time as mentioned on the merit-list of the respective programme in which admission is offered. In case any candidate fails to pay the Admission fee within the stipulated period, the offered admission shall stand withdrawn and the other candidate in the order of the merit from the merit-list will be considered for admission.
- 9. All the admitted candidates shall have to submit Migration/Transfer Certificate from their respective previous University/College/School positively before **13**th **October 2024.**
- 10. Admission granted by the University is considered as "Provisional Admission". All admitted candidates are required to bring the "Fee Receipt" generated through SAMARTH along with the necessary "Original Educational Documents" establishing the eligibility at the time of document verification schedule. The schedule for document verification will be communicated through the University website.

The classes would commence accordingly. All the candidates are hereby informed to keep browsing the University website for an update.

- 12. Any candidate who has been granted admission in any round and if such a candidate wishes to cancel the admission, the process of cancellation must be carried out through the SAMARTH Portal Login of the concerned candidate. Cancellation of admission via email/tele-communication/any other mode of communication (Except through SAMARTH Portal Login) shall not be entertained into by the University. The refund of the Admission fee as per the UGC Guidelines as amended from time-to-time will be initiated after completion of the admission process (Admission cancellation is mandatory through SAMARTH Portal Login).
- 13. As per the orders of Hon'ble Supreme Court of India, ragging of any kind is prohibited within and outside the premises of the University. Any candidate found guilty of being involved in ragging and/or abetting ragging, is liable to be punished appropriately as per rules of the University/UGC guidelines as amended from time-to-time.
- 14. If any candidate's certificates including Degree certificate, Birth certificate, Caste or Income certificates etc., are found fake/fabricated/falsified at any point of time during or after the course of study, the admission of such a candidate shall be cancelled by the University or if degree has been awarded to such a candidate, the awarded degree will be declared "Null and Void".
- 15. The University holds the right to cancel the application and admission of any candidate for wrongful submission of facts pertaining to qualification, reservation and/or any other matters without assigning any reason(s) thereof whatsoever.
- 16. It will be the responsibility of the candidate to browse the University website regularly for any updates about the admission process.
