1. The Merit-list of provisionally selected candidates in the following Post-graduate programme is uploaded on the University website https://www.cug.ac.in. All candidates are advised to visit the University website regularly for admission related information and updates.

2. Admission Procedure:

- Merit List and Fee Payment: Provisionally selected candidates are hereby informed to pay their Admission fee to confirm the admission in respective programme within the stipulated time [As mentioned on the respective merit-list(s)].
- Provisional Admission: Admission to the Central University of Gujarat shall be subject to the condition that an applicant fulfilling all the eligibility criteria as mentioned on the University website at the time of the admission. It is the applicant's responsibility to ensure fulfilment of the eligibility criteria for a respective programme. Admission offered at the first instance by the University is considered as "Provisional Admission".
- Verification of Documents: All candidates are required to produce all necessary "Original documents" establishing their eligibility at the time of document verification schedule as communicated by the Central University of Gujarat along with the "Admission Fee Receipt" generated through SAMARTH eGov Portal. The schedule for

3. Eligibility and Qualifying Examination:

- A candidate appearing for admissions at CUG through CUET-PG 2025 must have appeared in the final examination of the qualifying degree and declared "PASSED" and should possess the minimum eligibility as per the eligibility criteria of the respective programme as mentioned.
- Applicants awaiting the result of qualifying examination may also apply for the concerned programme, however, their admission shall be subject to PASSING the qualifying examination obtaining the minimum eligibility as per the eligibility criteria of the respective programme.
- Those candidates whose result of qualifying examination is not declared at the time of admission; they will be "*Provisionally Admitted*" for their respective programme at CUG. If such a candidate fails to secure the required minimum eligibility for admission as per eligibility criteria of respective programme and/or "FAIL" at the qualifying examination, as the case may be, their admission would be liable to be cancelled without assigning any reason(s) thereof whatsoever.

4. Documents Submission:

- **Migration/Transfer Certificate**: All the admitted candidates shall have to submit Migration/Transfer Certificate from their respective previous University/College/School positively on or before **13**th **September 2025**.
- A candidate meeting the minimum eligibility requirement is required to submit the relevant document of the qualifying examination to the Office of Controller of Examinations on or before **13**th **September 2025**, failing which the admission shall be liable to be cancelled without assigning any reason(s) thereof whatsoever.
- During admission, if a candidate is not able to provide some of the necessary documents/certificates, the admission shall be considered "*Provisional Admission*". The last date of submission of any of the pending documents/certificates is 13th September 2025 failing which the admission shall be liable to be cancelled without assigning any reason(s) thereof whatsoever.

5. Payment of Admission Fee:

• The selected candidates shall be required to pay the requisite Admission fee within the stipulated time as mentioned on the respective merit-list of the concerned programme in which admission is offered. In case any candidate fails to pay the admission fee within the stipulated period, the offered admission shall stand withdrawn and the other candidate in the order of the merit-list will be offered the admission.

6. Cancellation & Refund:

• Any candidate who has been granted admission in any merit-list and if such a candidate wishes to cancel the admission, <u>the process of cancellation must be carried out through the SAMARTH Portal Login of the concerned candidate</u>. Cancellation of admission via email/tele-communication/any other mode of communication (Except through SAMARTH Portal Login) shall not be entertained into by the University. The refund of the Admission fee as per the UGC Guidelines as amended from time-to-time will be initiated after completion of the admission process (Admission cancellation is mandatory through SAMARTH Portal Login).
