The National Testing Agency (NTA) has published the result of CUET (UG) 2025. The Counselling cum Registration process for admission in Four Year Undergraduate Programmes of Central University of Gujarat will be conducted in the following manner:

- Candidates desirous to take admission in a programme of Central University of Gujarat are required to participate in online counselling cum registration process as per following schedule:

After the last date of online counseling cum registration, the University will declare the list of the provisionally eligible candidates and the 1<sup>st</sup> merit list on the University website.

Candidate must fulfil the following conditions:

- Those student with a valid CUET (UG) 2025 Score declared by NTA with the respective subject paper required for the concerned programme as notified on the University website are eligible to apply for Counselling cum Registration process.

- **Provisional Admission:** Admission to the Central University of Gujarat shall be subject to the condition that an applicant fulfilling all the eligibility criteria as mentioned on the University website at the time of the admission. It is the applicant's responsibility to ensure fulfilment of the eligibility criteria for a respective programme. Admission offered at the first instance by the University is considered as “Provisional Admission”.
- The admission of a candidate is liable for cancellation if the eligibility claimed by the candidate is found to be incorrect and inconsistent during or after the admission process.
- The candidate must refer to the list of Programmes, Programmes specific Eligibility Criteria, Fee Structure and other relevant information published on the University website.
- The shortlisted candidates in the merit list can secure their admission to the FYUG programme by depositing the Admission fees within stipulated time, as mentioned on the merit list and/or communicated to them.
- If a candidate fails to pay the Admission fee within the stipulated time limit, the offer of admission shall be withdrawn and the seat will be offered to the next candidate on the merit list.
