Foreigners Regional Registration Office (FRRO) Information

According to Indian Governmental policy all Foreign Nationals arriving in India are required to register themselves at the Foreigners Regional Registration Office (FRRO) **within 14 days** after arrival but only after registering at CUG.

Form S- (Foreign Students Information System) is used to capture the information about foreign nationals admitted in Indian Educational Institutions. It is mandatory for all educational institutions in India admitting foreign students for various courses to register themselves first.

Documents required for the FSIS (Foreign Students Information System) No.

- 1) S Form and Bonafide Certificate (Download from the website and duly filled in and signed and stamped by the concerned Authorities mentioned in the form)
- 2) Copy of the admission/registration folio
- 3) Passport copy
- 4) Visa copy
- 5) Residence proof from your hostel/place of stay
