Plenary Session-I

Theme: "Relevance of the vision of Mahamana in the context of Modern Education"

The session started by the chairperson of the plenary session Prof. Rama Shankar Dubey, Vice-Chancellor, Central University of Gujarat by reflecting upon the magnificent personality of Mahamana Pandit Madan Mohan Malviya and his relevance in the current society and education system. He discussed some of the significant incidences from Indian



history and the contribution of Pandit Madan Mohan Malviya which is not known widely.

After giving a glimpse of some of the principles and contributions of Mahamana he handed over the session to the resource person for the plenary session- I, Prof. B.K Tripathi, Director of IUCTE, BHU. The resource person started the session by signifying the role of Mahamana not only in the Indian context but also in the global context. He quoted Mahatma Gandhi who once said, "Mere Charitra par Daag ho Sakta hai par Pandit Ji Ke Charitra par Nahi". Such charismatic was the personality of Mahamana. Mahamana always emphasized on the overall development of any individual. His vision was based on humanitarian ground. In 1904, he chose education to impart the lesson of humanity and with this purpose, he proposed for the establishment of Banaras Hindu University in 1905. He practiced law and journalism. He was also the chairman of the Hindustan Times from 1924 to 1936. He studied all ancient Scriptures, Vedas and Upanishads and therefore for him Hinduism was not just a sect but a way of life. The resource person then talked about the vision of Mahamana in the field of Education. He mentioned about Pandit Madan Mohan Malviya National Mission on Teachers and Teaching, a scheme of Central government inaugurated in 2014 to bring reforms in the area of teaching. He said that the idea of peer learning and creative learning which is considered to be a shift from behaviorism to constructivism theory is so much in demand today but Mahamana in 1916 only propagated such constructive ideas. Also, the parameters of quality education, learning outcome, and interdisciplinarity of the subject are also some of the widely discussed topics in today's education system which was also talked by Mahamana long time back. He favored education of any subject with values along with the study of ancient Indian knowledge and cultural heritage. Therefore, currently, work is going on to interpret and understand the vision of Mahamana in the education system which would be based purely on the authentic sources available. The resource person then ended his talk by saying that as students, teachers, and educationists, we all should relook and reflect the ideas of Mahamana in the current educational scenario.

The chairperson concluded the session by sharing two incidences regarding the commitment of Mahamana towards ensuring a good quality of teachers in the institutions. In the year 1931, he got impressed with the knowledge of a young professor of mathematics in England and asked him to join BHU as head of the department in mathematics where he ensured him to provide autonomy for implementing new ideas in his subject. Another was the recruitment Ranganathan, as head of the Library-science department. These two incidences showed that Mahamana never wanted to compromise with the quality of the teacher in his institutions. In the end, the chairperson concluded the session by saying that the need of the time is that education for students should include a humanitarian value that would help in the process of nation-building.

The first plenary session concluded with a vote of thanks by Dr. Shamim Aara Hussain, Assistant Professor, School of Education, Central University of Gujarat.

<u>**Theme**</u>: "Pandit Madan Mohan Malviya's Axiological Paradigm for Value Education"

The session started with the chairperson inviting the resource person for the second plenary session Prof. Harikesh Singh, honorable Vice-Chancellor, Jai Prakash University, Chhapra, Bihar. The resource person began the session by saying that education itself has inherited

When our gross enrollment ratio is increasing them what can be the reason leading towards the lack of apathy among individuals. Why are we struggling to achieve the synthesis between quantity and quality? This is because though we are getting educated but we are not able to dissolve our ego. The first quality that an individual should achieve after becoming educated is the dissolution of the ego.

In an affluent society, the individual is facing the problem of isolation, impatience, and excess of aspiration. We are forgetting our roots. So rather than becoming a conscious being as told by Aurobindo Ghosh, we are getting driven by our selfish need. The resource person expressed his concern about the current education system with the quote of Rabindranath Tagore, "we are busy in decorating cage but the bird inside is thirsty". That means rather than helping a child to attain the knowledge we are busy working on other aspects in the field of education. This leads to the commodification of education in the current society where individuals even after becoming doctor or engineering are not doing their job with honesty and integrity. He also talked about the objective of education as defined in the report by UNESCO in 1970 titled "Learning to be" and of 1996 titled "Learning the treasure within". The aim of education should be to attain knowledge of higher-order (Pragya). We should go for perennial knowledge rather than attaining a temporal one. Therefore, there is a need to adopt a holistic perspective where we can move towards the idea of "we the people".

The resource person moving his discussion further said that education is the process of optimization of innate capabilities. It is also the process of socialization and humanization. There is a need for invoking consciousness among individuals regarding what is right and what is wrong. The inculcation of value would happen only when an individual would face an adverse situation and calamity, only then they would work towards its eradication and help masses who are the most underprivileged in the society. Therefore, when the current education system failed to inculcate values among individual then we started looking at education and values separately which is a contradiction.

After creating marginalization in society, these days we are talking about inclusiveness. Therefore, there is a need to aim for holistic education and human dignity. The resource person ended the discussion by emphasizing the role of teachers who can help any individual to become a conscious citizen. He ended his talk by saying the famous lines, " when a teacher runs, student walk, when a teacher walks, student crawl, when a teacher crawls, student stand, when a teacher stands, students sit, when a teacher sits, student sleep and when a teacher sleeps, students die".

The second plenary session ended with the chairperson expressed his gratitude towards the resource person by highlighting the last and significant point that emphasized on the role of teachers. He said that the practice of teachers should be based on moral conduct as teachers prepare students to achieve their capabilities according to their values. The values of Sanatana culture aims towards the nation-building that should be inherited in our current education by studying our ancient text, scriptures, heritage, etc. The second plenary session ended with a vote of thanks by Dr. J. N Amin, Associate Professor, School of Education, Central University of Gujarat.

Round Table 1A

In the room no. 1A, 19 participants shared their views on the contribution of Pandit Madan Mohan Malviya towards society, education and higher education. The session began with the introduction and welcoming of the chairperson, Dr. G.R Angadi, Associate Professor, School of Education, Central University of Gujarat and co-chairperson Dr. Kusum Yadav, Head of Department, R.H Patel English Medium, B.Ed. College, Faculty of Education, Kadi Sarva Vishvavidyalaya, Gandhinagar, Gujarat. The chairperson and co-chairperson then took attendance of the participants present in room no. 1A. The first participant, Chetankumar Sumanbhai Patel discussed the role of Pandit Madan Mohan Malviya in promoting education for the weaker sections of the society. The second participant, Dr. Rachna Mishra talked about the contribution of Mahamana in the higher education of the society. She said that the foundation of Banaras Hindu University was a milestone in the field of higher education where the traditional form of rote learning was replaced by practical and scientific learning. The third participant Avani Mukundray Bhatt expressed her views on the significance of studying the Sanskrit language as part of Sanatan culture as propagated by Mahamna through his teaching. Dr. Parshuram Dhaked, the fourth participant talked about the views of Mahamana towards the holistic development of students, from being physically fit to having a strong character that would contribute to the process of nation-building.

The fifth participant, D. Kalpeshkumar Vitthabhai Patel, talked about the decline of values in our current society and the contribution of Mahamana in imbibing values among students through education. He said that Pandit Madan Mohan Malviya wanted University to prepare doctors, engineers, professors along with preparing them to become responsible citizens of their country. The sixth participant Selvamari S and seventh participant R Udhaya Mohan Babu and ninth participant Dr. Santosh Kumar R expressed their views on the contribution of Mahamana towards economic advancement. They said that he was in favor of industrialization that would help our nation to stand in an international competition. They said that Mahamana wanted the integration of science and technology along with the study of

our ancient culture and tradition which would help in the holistic development of an individual. The eighth participant Dipankar Dey reflected on the contribution of Mahamana with respect to the current New Education Policy, 2016. The tenth participant, Chauhan Nilkamal Anilbhai expressed her thoughts on the views of Pandit Madan Mohan Malviya towards a disciplinarian classroom. She quoted his saying where he said that rules are made for man and not man for the rules. The next participant Ram Niwas tried to reflect on the views of Mahamana with respect to inclusive education.

The next participant Akhtar Parvin Gauri shared two stories from the life of Mahamana that showed his dedication and devotion towards his motherland. First paper presenter started by saying that Malviya was a great visionary and contributed a lot to the education field and to the moral values among mankind. Second presenter initiated further by adding that Pandit Madan Mohan Malviya always worked for the unification of the society. He worked for the issues like untouchability and caste system also. He also gave examples where it was told that Pandit Madan Mohan Malviya was a person with beliefs for the society and worked for the welfare of the nation and the society respectively. Other presenter talked about Pandit Madan Mohan Malviya's ideology for women education, child marriage, remarriage of girls at young age,etc. He continued that Malviya was a great soul and always focussed upon equality of any kind. Fourth paper presenter continued further by stating that he was great educationist, great visionary and patriarchal. He contributed to the society by being a lawyer also. He was a person who believed in Hindu Muslim unity, society free from caste issues and religion issues. Fifth presenter shared his personal experience of issuing a book in the library which was on Pandit Madan Mohan Malviya for the first time. The presenter added that Malviya gave four different Purushatra for acquiring knowledge and stated that education at primary level should be provided in mother tongue itself. Pandit Madan Mohan Malviya also focused on making Sanskrit as a base for other languages and personality of students is based on the personality of teachers. Thus, teachers should make every effort to bring out the best in every child. Last paper presenter focused upon Malviya's personality as a human being as he was a versatile journalist, politician social reformer, activist and was known a 'Mahamana' for the same. He also talked about women education, inclusion, human behaviour and vernacular language.

Overall, everyone talked about Pandit Madan Mohan Malviya's great contribution in the society as a social reformer and in the field of education. Everyone added their views to the prevalent knowledge base in their respective ways. The session was open for discussion among all the participants and ended with a brief introduction about each and every one respectively. Afterwards, there was tea break and valedictory session.
