The Director (Admn.), Ministry of Education (Shiksha Mantralaya), Govt. of India, New Delhi has informed that the Ministry of Human Resource Development shall be henceforth officially known as "**Ministry of Education (Shiksha Mantralaya)**", in pursuance of the notification issued by the cabinet secretariat notifying amendments under schedule-I and schedule-II of the Govt. of India (Allocation of Business).
