The Director (Admn.), Ministry of Education (Shiksha Mantralaya), Govt. of India, New Delhi has informed that the Ministry of Human Resource Development shall be henceforth officially known as "Ministry of Education (Shiksha Mantralaya)", in pursuance of the notification issued by the cabinet secretariat notifying amendments under schedule-I and schedule-II of the Govt. of India (Allocation of Business).

Consequent to the change in the name effected by Govt. of India as above, all official communications erstwhile addressed to Ministry of Human Resource Development shall be henceforth addressed to "Ministry of Education (Shiksha Mantralaya)". All name plates, stationery and other material of public display and advertisements, websites, etc. should reflect the changed name viz. Ministry of Education (Shiksha Mantralaya) substituting Ministry of Human Resource Development whenever occurring. The change of name should also reflect in all contracts and agreements henceforth signed or entered into.

In view of above, all are requested to make necessary changes accordingly, substituting Ministry of Human Resource Development as "Ministry of Education (Shiksha Mantralaya)".
