Sub: Closing of Central University of Gujarat due to spread of second wave of COVID-19.

1. All of us are aware that cases of COVID-19 are rising daily everywhere including the Central University of Gujarat, where about 20-25 staff members have been reportedly infected with COVID-19 and one of our faculty member Prof. Indrani Banerjee passed away, which is a huge loss to the University.
2. In view of the above, Hon'ble Vice Chancellor had called an emergent online meeting of all Deans and Officers on 11/04/2021 at 5:00 P.M. The following resolutions have been unanimously adopted in this meeting for immediate compliance: -
 - a. University will remain closed from 12.04.2021 to 16.04.2021. After this period, situation would be reviewed, and further decision would be taken accordingly.
 - b. All teaching staff will continue to work from home and will engage classes for the students through online mode, as hither-to-fore.
 - c. All Non-Teaching staff of the University shall continue to work from home in online mode.
 - d. In case of any requirement, concerned staff will be asked to attend the University with all precautionary measures as mentioned in the guidelines issued by MHA/MHFW and the University.
 - e. All Teaching and Non-teaching staff should provide their contact details i.e Mobile No., email id, etc to their office so that they may be contacted in case of emergency.
 - f. All Teaching and Non-teaching staff are also hereby directed **not to leave their headquarters/duty station without permission** of the competent authority.
 - g. **Essential Services such as Hostel Administration, Maintenance Section, Health Centre related activities shall continue as usual.**
