## Agenda No.07/34/EC/22/02/2021 To ratify Booking of Mahatma Mandir Convention & Exhibition Centre for 3rd Convocation Ceremony.

**Resolution 7:** Hon'ble Vice Chancellor explained to the House that it was earlier thought to hold 3<sup>rd</sup> Convocation of the University within the campus of Sector-29, but this space after measurement appeared to be insufficient in the context of (i) Hon'ble President of India was to grace the occasion as Chief Guest and (ii) social distancing need to be maintained due to COVID-19 pandemic. Therefore, on the suggestion of Hon'ble Chancellor and after the visit of Members of Organising Committee of the Convocation to Mahatma Mandir Convention & Exhibition Centre, it appeared that Mahatma Mandir Convention & Exhibition Centre would be suitable for holding 3<sup>rd</sup> Convocation Ceremony of Central University of Gujarat. This was an emergency like situation and very few days were left to hold the Convocation. Therefore, the venue Mahatma Mandir Convention & Exhibition Centre was booked without loosing much time. In view of these facts, the House ratified the booking of Mahatma Mandir Convention & Exhibition Centre for 3<sup>rd</sup> Convocation Ceremony of Central University of Gujarat.

## Agenda No.08/34/EC/22/02/2021 To ratify engagement of Event Management agency M/s. Drashti Communication for 3<sup>rd</sup> Convocation Ceremony.

**Resolution 8:** Hon'ble Vice Chancellor narrated the circumstances under which the decision to engage M/s. Drashti Communication was taken for event management. This was also an emergency like situation where very few days were left to hold convocation. Further, Gujarat Technological University (GTU) had earlier engaged M/s. Drashti Communication for its convocation. In view of the exigencies of the situation, and noting the performance of M/s. Drashti Communication the House ratified the engagement of Event Management agency M/s. Drashti Communication for 3<sup>rd</sup> Convocation Ceremony of CUG.

# Item No. 09/34/EC/22/02/2021 To ratify the panel of experts of the Selection Committees for appointment of teaching and non-teaching staff through direct recruitment

**Resolution 9:** The House ratified the panel of experts of the Selection Committees, for the selections held recently for appointment of teaching and non-teaching staff through direct recruitment. The House further authorized the Vice Chancellor to go for the names other than those approved earlier,

**Resolution 10:** As the brief of the agenda was placed before the House, the members of the House placed on record their appreciation for the Vice Chancellor who not only took a lead to organize a seminal event like Convocation of the university but also managed to elicit acceptance of the Hon'ble President of India to the university's invitation to be the Chief Guest and Hon'ble Education Minister of India to be the Guest of Honour of the event. The House then went through the list of students eligible for award of degree and CUG Medals in the 3<sup>rd</sup> Convocation of Central University of Gujarat and approved it.

To consider and approve to accept Endowment fund of rupees 03 lakhs for inducting Vidhya Devi Agrawal Gold Medal for the M.A. (Economics)

**Resolution 12:** Hon'ble Vice Chancellor pointed out that it was a matter of great delight that Prof. Sarita Agrawal, Dean, School of Sciences had given endowment fund of Rs. 3,00,000/- (Three Lacs) to the university to institute Gold Medal in the name of her mother Smt. Vidhya Devi Agrawal, to be given to the student scoring the highest marks in the last semester of M.A. (Economics) every year from the interest of the endowment. Further, since the endowment interest for the current academic year was not generated, she had donated the gold medal for the eligible student who would get it during the Third Convocation of the university.

Further, Hon'ble Vice Chancellor underscored the fact for the kind consideration of the House that Smt. Vidhya Devi Agrawal Gold Medal will be awarded to the student scoring the highest marks in the last semester of M.A. (Economics) even if the same student becomes eligible for the university gold medal which is based on performance in the entire program. The House considered all these aspects and approved the acceptance by the university of the Endowment Fund of Rs. 03 lakhs for instituting Vidhya Devi Agrawal Gold Medal for the student scoring the highest marks in the last semester of M.A. (Economics).

**Resolution 14:** While discussing the agenda Hon'ble Vice Chancellor pointed out that in line with the suggestions of the UBC and FC, the draft MoU needs to be amended. During the discussion unanimous opinion emerged that during the tendering process a clause should be incorporated that tender would be awarded only to those firms with a minimum turnover of, let us say Rs. 1,000/- crore per year during the last 3 years, so that only well reputed firms would participate in the tendering process The House perused the draft MoU and accorded approved to it while underscoring the need to clearly specify issues in the MoU like penalty consequent upon delays and mandatory approval of university before contracting and subcontracting by CPWD. In order to put in further checks and balances, the House authorized the Vice Chancellor for any omission and/or addition to the clauses in the MoU.

**Resolution 15:** In view of the code of conduct in force in Gujarat due to the elections in local councils, the House deemed it fit not to open the sealed covers carrying recommendations of the Selection Committees for appointment of teaching staff through direct recruitment and authorized the Vice Chancellor to go ahead with opening the envelops and doing the needful in this regard after the code of conduct is formally lifted by the EC of Gujarat.

### To consider and approve Proposal for starting MA programme in Hindu Studies from AY 2021-22

**Resolution 17:** Hon'ble Vice Chancellor brought to the notice of the House that the agenda item was proposed by Prof. Sanjay Satyarthi, esteemed member of the Academic Council of university and was duly approved by the Academic Council in its meeting dated 22<sup>nd</sup> February, 2021.
