This is in continuation to my previous letter dated 08 March 2021 wherein I shared with you the information about AIU Collaboration Portal. I had requested you to fill up the information about the best departments/facilities of your university in the AIU Portal, which you would like to showcase in order to promote collaboration with national and international universities.

As you know, AIU launched International collaboration portal for member universities in line with the National Education Policy 2020, to allow them to showcase their best department which are ready for international collaboration in the areas of Research, Faculty and Student exchange etc. AIU has been receiving several requests from foreign HEIs and other professional bodies to collaborate with Indian universities in specific areas.
