Sub: Constitution of school level committee to undertake the Academic and Administrative Audit exercise of schools of the University.

Ref.: Approval of Hon'ble Vice Chancellor dated 28.05.2021.

Preamble:

As a prelude to the preparations to get the Central University of Gujarat reassessed and re-accredited by NAAC in 2nd Cycle, the Academic and Administrative Audit of all the Schools and Centres of the University is to be carried out by the internal AAA committee latest by June 30, 2021 as the monitoring and evaluation of the institutional processes requires a carefully structured system of internal and external review. The NAAC expects the Institutions to undertake continuous Academic and Administrative Audits (AAA). As per this advisory, the University has to constitute an internal Academic and Administrative Audit Committee for audit, as it prepares for the Cycle 2 reaccreditation by NAAC during 2021.

Notification:

Hon'ble Vice Chancellor has constituted following internal committees with mandate that the Committees shall undertake the Academic and Administrative Audit exercise of various schools considering all seven criteria of NAAC (attached herewith), complete the exercise by June 30, 2021 and the conveners should submit their reports to the administration latest by July 5, 2021.
