Sub: Reopening of the university campus for offline academic activities.

Ref.: Minutes of Deans Committee meeting dated 16.07.2021.

In compliance with the guidelines of Govt. of India, University Grants Commission and Govt. of Gujarat, issued from time to time to contain and fight back the pandemic situation, the university had shifted all teaching-learning and examination processes pertaining to UG and PG courses to online and virtual modes. Recently, the degree of Covid-19 transmission has declined countrywide, and specifically in Gujarat, substantially. The matter of reopening of the university campus for offline academic activities was discussed in the above-referenced meeting and a consensus was built about reopening of the campus in phase manner for students of UG and PG programs being offered in the university from 06th September, 2021.

Hence, students, faculty members and other stakeholders are herewith informed that the academic activities in the university will commence in offline mode & simultaneously continue in online mode for those students who cannot attend classes in offline mode from 06th September, 2021 for students of 3rd and 5th Semesters of PG and UG programs respectively. It is to be noted that everyone is required to observe Covid-19 appropriate behaviour while on campus as well in hostels. Theory classes and practical sessions will be held following the mandatory social distancing norms. Face masking, at least one dose of vaccine and other necessary hygiene protocols will be mandatory for entering the different premises of the university. All concerned are herewith informed to take necessary action in this regard.
