**Sub:** Constitution of Committees for preparation of common academic time-tables for programs offered at University campuses at Sector-29 and Sector-30 in AY-2021-22.

**Preamble:**

In view of space crunch faced by the University on its transit campuses, increases in the number of programmes as well as batches and promising response on online application portal for admission in various programmes offered at University in AY-2021-22, it has been become necessary to undertake proper planning of the way in which academic space to students of different streams and specialization in both the campuses of the University is allocated. Such a planning would effectively pre-empt issues of classroom clashes, unutilised time-slots and other such problems. Accordingly, two separate Time-Table Committees are herewith constituted for preparing two separate academic time-tables of programmes offered at Sector-29 and Sector-30 campuses of the University.

**Terms of Reference (TOR)of the Committees:**

The Committees are mandated.

- 1) To prepare common time-tables for all academic programs being run at Sector-29 and Sector-30 Campuses of University, in such a way that available classroom space is effectively utilized for engagement of all the students.
- 2) To resort to two-shift model of academic functioning, if required, so that issues of classroom clashes, unutilised time-slots and other such problems can be effectively pre-empted.
- 3) To ensure that all PG programmes offered at the University are allotted morning classroom sessions so that the same space can become available for other programmes in the afternoon.
- 4) To interact with each other and allocate cross-campus classroom spaces for a few programmes based on requirement and availability especially for multidisciplinary and holistic education papers to be taught under NEP mandate.
- 5) To devise School-wise time-tables for practical/laboratory sessions in consultation with respective faculty members so as to make optimum utilization of scarce lab infrastructure.
- 6) To include furniture requirements keeping in mind the expected increase in student strength for all programmes.

The Chairpersons of both the Committees shall submit common time-tables for both campuses and practical time-table of each School/Independent Centre by **18/11/2021** to Registrar's Office for approval of Competent Authority.
