
The vehicle will be available for inspection upto **07/02/2022** at Central University of Gujarat, Near Jalaram Temple, Sector-29, Gandhinagar.



- (c). Bids received without Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the Commercial Banks or payment online towards Earnest Money will not be considered and shall not be accepted.
- (d). The successful bidder will be required to deposit the bid amount by means of Bank Transfer/ Deposit Slip in Canara Bank A/c No. 5999132000003. Demand Draft drawn in favour of Registrar, Central University of Gujarat within two working days of the acceptance of the bid.
- (e). The Earnest Money of the successful bidder (H1 Bidder) will be released only after deposit the sale proceeds and registration Certificate of the vehicle transferred in his name within seven working days at his own cost expeditiously. Earnest Money will not be adjusted as sale proceeds and be forfeited if he fails to honour the bid.
- (f). The delivery of the sold vehicle will be arranged only after the successful bidder (H1 Bidder) submits documentary evidence in support of residential status (Ration Card/ Voters ID Card in case of individual and Registration Certificate in case of firms etc.)


