At the outset, the Registrar welcomed all the internal and external members of the Executive Council and requested the ICT team to recite audio of the Kulgeet.

In his introductory remarks, Hon'ble Vice Chancellor welcomed all the external and internal members of the Council and gave a detailed account of various activities undertaken by the University. He intimated the House that the University has made heartening progress since the last meeting of the Executive Council held on 31.01.2022. He then proceeded to recount a few of the major achievements of the university.

Hon'ble Vice Chancellor informed the House that the University has implemented the mandate of NEP-2020 as directed by the UGC and MoE from time to time. As a part of the implementation, the University has introduced a compulsory non-credit course in Holistic Education both at UG and PG levels as well as Multidisciplinary courses as minor electives. That apart, the university has registered on the portal managing Academic Bank of Credit and repurposed the syllabi of all UG and PG programs within the LOCF laid down by UGC. Further, the university has successfully implemented UGC Regulations on offering MOOCs through SWAYAM platform. He further informed the House that in spite of the pandemic, the University has followed the Academic Calendar prepared and circulated by UGC and has imparted education online, for sometimes in blended mode and now fully in offline mode. Despite the bottlenecks created by the pandemic, the University has successfully conducted examinations and declared results in time. The University has carried out recruitment in the meantime and appointed new faculty members as well as processed the applications for CAS promotions of existing faculty members. This year, the University is going to offer admission to Bachelor and Master programmes through tests conducted by NTA.

On the research and development front, the University has strengthened the Central Instrumentation Facilities by upgrading and repairing the scientific instruments housed therein. Further, several patents have been filed by the faculty members of the university. In addition to these, two faculty members of the University viz. Prof. Dinesh Kumar and Dr. Kulhari have figured in the prestigious list of the "World Top 2% of Scientist" prepared by Stanford University, ScienceTech Strategies Inc., USA and Elsevier while Prof. Atanu Mohapatra has bagged the prestigious Atal Behari Vajpayee IPSA National Award. For the first time in the history of the university, Dr. Shiju Sam Varughese has been awarded Fulbright Nehru Academic and Professional Excellence Fellowship recently. Further, Dr. Rajesh Vasita has been awarded DST-SERB Fellowship for International Research Experience under which he will be working for 06 months at Terasaki Institute for Biomedical Innovation, Los Angeles, California, USA. One of the students at the university has been awarded full travel grant to participate in the 47th National Organic Chemistry Symposium 2022 to be held at University of California, USA. The University Volleyball Team secured 1st position in Gandhinagar Volleyball Tournament and a student secured 1st rank in Disc Throw Further, the Central University of Gujarat has been granted Dr. Ambedkar Centre for Excellence for which an MoU has been signed at BHU recently. The construction in the 1st phase of infrastructure projects of the permanent campus of the university has been started and going in full swing.

The Members congratulated the Hon'ble Vice Chancellor and entire CUG fraternity for their commitment to the institution which is visible from the achievements and progress made by the University. Then, the Hon'ble Vice Chancellor took up the agenda of the meeting.

After due deliberation the Executive Council approved the appointment of the officer, so nominated by Indian Audit & Accounts Department, as Internal Audit Officer (UR-01) in the university on deputation for a tenure of 05 (five) years or till superannuation in his parent organization, whichever is earlier, subject to the condition that the initial appointment will be for the period of one year only, which may be extended further depending on the evaluation of his satisfactory performance and integrity and that his employment can be brought to an end by the university at any point of time by giving 30 days notice in writing or salary in lieu thereof.
