- 1. Admission to any academic programme in this University (CUG) shall be subject to applicant fulfilling all the eligibility criteria as mentioned in the prospectus. It is the sole responsibility of the applicant to ensure that she/he fulfils the eligibility criteria for a particular programme where she/he is an applicant.
- 2. It must be noted that allowing a candidate to appear in the Entrance Test and Interview and completing the process of provisional admission does not entitle a candidate for confirmed admission if she/he <u>fails to fulfil</u> the required eligibility conditions for admission as prescribed in the prospectus and as amended and displayed on University website from time to time.
- 3. The documents and eligibility will be verified at the time of admission and subsequently at any stage during the pursuance of the course/programme or thereafter. If it is found at any point of time that a candidate has failed to fulfil the minimum eligibility requirements, the provisional admission or degree shall stand cancelled forthwith.
- 4. Candidate must have appeared in the final examination of the qualifying degree and declared passed with minimum required percentage as per the eligibility criteria mentioned in prospectus before admission. However, their admission shall be subject to minimum eligibility marks in the qualifying examination and they may be allowed to seek admission only on the submission of their final year mark-sheet on or before the last date of admission.
- 5. If a student is not able to provide some of the requisite documents/certificates except the qualifying examination mark-sheets at the time of admission, she/he shall be considered as provisionally admitted. Last date of submission of any of the pending documents/certificates is **20**th **January 2023** failing which the student shall be liable for her/his admission to be cancelled.
- 6. If any candidate's certificate is found to be fake/fabricated/falsified at any point of time, the admission of the student shall be cancelled or in case the degree has been awarded, the same will be declared null and void.
- 7. Provisionally selected candidates are required to complete the enrollment process online between 22nd December (at 08:00 PM) and 25th December 2022 (upto 12:00 Midnight).
 - Login id and password for the enrolment will be same as used at the time of Ph.D. registration process.
- 8. A candidate will only be admitted to one programme of study even if she/he has qualified to more than one programme. Change of programme is not allowed once the enrollment to a programme of study has been completed.
- 11. The candidates under reserved categories i.e. OBC (Non-creamy layer), SC, ST, EWS and PWD should produce the relevant certificate in the prescribed format issued by a competent authority in support of their claim without which their claim will not be

considered. If a candidate fails to produce such certificate, her/his admission shall stand cancelled and the seat will be offered to the next candidate in the merit list.

No student can claim to University for the hostel facility or seat as a matter of right. If hostel seat is allotted, subject to availability, the students have to pay the hostel fee separately.
