**Subject: Power Staggering for Sector-29 & 30 campuses of CUG to avoid frequent tripping and to control the excess electrical power demand.**

It is observed that of late there have been frequent tripping of power line and damage to the electrical fixtures and installations owing to overload and due to indiscriminate power consumption coupled with extreme heat conditions prevailing in Gandhinagar.

The majority electrical load of Split AC and hence the following time schedule decided to switch off the Split AC units with immediate effect:

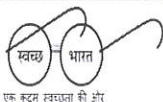

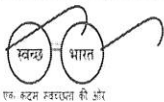
