The Central University of Gujarat invites applications from the eligible candidates for appointment of 'Guest Faculty' for 01 (One) post in the **Centre for Health, Culture and Personality Development (CHCPD)** for the period of six months as per UGC Guidelines/UGC Regulations.

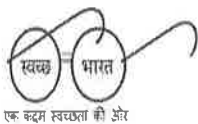
Honorarium (as per UGC revised guidelines): Rs.50,000/- (Rupees fifty thousand only) per month.

Educational Qualifications as per UGC Regulations 2018:

- i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in Hindu Studies / IKS / Sanskrit / Philosophy / Yoga Studies subject from an Indian University, or an equivalent degree from an accredited foreign University.
- ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET :

The candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;

- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET shall also not be required for such Masters Programmes in disciplines for which NET is not conducted by the UGC, CSIR or similar test accredited by the UGC.

The other details, terms and condition are as per UGC Regulations 2018, Revised Guidelines for enhancement of the Rates of Honorarium of guest Faculty and Central University of Gujarat from time-to-time. The renewal of the Guest Faculty for further six months shall be subject to satisfactory performance report from the concerned Chairperson/Dean and approval of Competent Authority.

How to Apply: Eligible candidate may apply in prescribed format as per **Annexure-I** along with two color passport size photographs, self-attested photocopies of relevant certificate, mark sheets and submit through Speed Post / Register Post to **“The Registrar, Central University of Gujarat, Sector-29, Gandhinagar-382030, Gujarat”** on or before **21/03/2025** (on working hours).

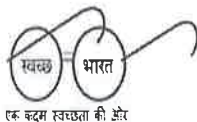
